The Seventh Circuit explained that the exclusionary rule does not apply to an illegal entry if there is overwhelming evidence of probable cause and a search warrant was planned before entry. The Second Circuit reaffirmed the principle that prolonging a traffic stop is not unconstitutional if the reason is supported by reasonable suspicion. The First Circuit extended the community caretaking doctrine to the home in finding officers' warrantless entry justified. In the continuing evolution of the stop-and-frisk doctrine, the Second Circuit ruled that officers need more than a belief that a suspect possess something illicit—they must reasonably believe the suspect may pose a threat. The Tenth Circuit ruled that an officer's 15-minute phone call to a national database was reasonable and did not impermissibly extend a traffic stop. The Seventh Circuit said that the smell of marijuana combined with a driver's "shocked" body language justified a trunk search. The Fourth Circuit tossed a man's gun convictions after the officers arrested the man at his girlfriend's residence without probable cause that he lived there.
